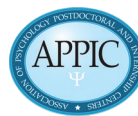

## Home and Community-Based Services (HCBS) Quality Initiatives

Liberty has extensive experience designing, developing, and managing large statewide quality programs in support of meaningful outcomes for individuals with I/DD.

**Person-Centered Practices:** Designing best in class quality programs, built around person-centered frameworks (e.g., Charting the LifeCourse, CQL).

**On-Site Provider Reviews:** Integrating quality with compliance in the review and support of quality service delivery.

**Critical Incident Management:** Performing reviews of over 90,000 annual critical incidents, reducing risk of recurrence.

**Mortality Reviews:** Designing mortality review systems, performing meaningful mortality reviews, and applying results for quality improvement.



## Independent Assessment Services

Liberty offers high-quality, independent assessments and related services for individuals throughout the lifespan to determine programmatic eligibility and appropriate level of care based on individualized service needs.

**Waiting List Management:** Conducting independent assessments of individuals on statewide waiting lists for I/DD services, followed by individualized navigation plans for immediate assistance.

**Access to Services:** Performing over 90,000 annual assessments for HCBS and other long-term care supports and services.

**Protective Service Investigations:** Processing over 45,000 reports of abuse, neglect, or exploitation assessed for risk and level of need each year.

**Supporting Tool Transitions:** Helping states transition to new instruments (e.g., SIS-A, interRAI).

**Advanced Analytics:** Converting data into meaningful information through robust technology and analytics.



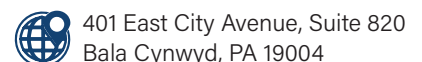
## Enhanced Clinical Programs and Services

Liberty's enhanced clinical programs and services are designed to support full participation within the community for individuals with I/DD who have the most challenging needs (e.g., forensic involvement, serious mental illness).

**Enhanced Clinical Support Teams:** Supplementing provider capacity through deployment of behavior analysts and mental health and medical practitioners.

**Intensive Residential Programs:** Providing short-term treatment and stabilization within residential settings.

**Intensive Individualized Transition Services:** Facilitating safe and effective transitions from congregate settings (e.g., ICF/IID, correctional facilities).
